1. The following changes are made to the Program Announcement:

a. In the Executive Summary, Part I paragraph 2 is changed to read as follows:

To be considered for award under this PA, full proposals must be received no later than **12:00 noon ET on 28 April 2008**.

b. In the Executive Summary, Part I paragraph 12 is changed to read as follows:

Award Schedule: The following is the anticipated award schedule associated with this PA:

c. In Part III Program Tasks, Tasks 1 and 3: Additional Specific Requirements, the following is added;

The program operates in English; however, for a large portion of the U.S. school population Spanish is the first language. The awardee must be capable of providing key communications in Spanish as well as English. Specifically, Attachments 3, 6 and 8 to this Program Announcement must be provided in Spanish. All translated materials will reference the English source

document. Additionally, the Awardee is responsible for making revisions as necessary and appropriate to the general message content and style of delivery for web content and general scientific news stories so that the information is more understandable to the audience as a result of cultural or geographical differences.

d. Part IV – Proposal Preparation, paragraph 1. Proposal Submission: the Due Date and Time is changed to **28 April 2008, 12 Noon ET (local time in North Carolina)**.

e. PART V – Evaluation, Negotiation And Award, Evaluation Factor 4: Past Performance is changed to read as follows:

Evaluation of this factor will include evaluation of the offeror's experience (both the experience of individuals proposed and the experience of the organization) in performing tasks similar to the PROGRAM TASKS listed in PART III. Thus, the offeror is requested to provide information for up to three (3) efforts that are currently active or that have been physically completed in the last **twenty-four (24) months** that represent recent, relevant and successful experience that relate to the Program Tasks. For each effort, offeror's are requested to provide the name, telephone number and email address for a point of contact that can verify such past performance. During its evaluation, the Government may verify this information and use such in the evaluation of this factor.
